


Figure 1. Battery Life vs. Vcc Supply Voltage




Figure 3. SC70 (Top View)




Figure 4. MicroPak™ (Top Through View)




Figure 5. AC Test Circuit




Figure 6. AC Waveforms




Figure 7. 5-Lead, SC70, EIAJ SC-88a, 1.25mm Wide


